

As anticipated, a number of noted owners and enthusiasts have come forth to volunteer their time, their support to the formation of the Club. These initial Directors are listed herein. They are available to all of us to help in anyway they can as we proceed onward to come together. Your Initial, Volunteer Directors have recently voted on a few issues on which I am pleased to report:

 It was initially proposed that we be known as: "STUTZ OWNER'S CLUB OF AMERICA".

The vote was not unanimous. Some feel that the name is too restrictive. Many great enthusiasts are no longer owners! Others felt America also was restrictive. Perhaps a third of the cars rest outside the U.S.A.? So....

Therefore, until further consideration can be given by the Directors and Membership, it seems appropriate to refer to our association as: "THE STUTZ CLUB".

2. The naming of the Club's Newsletter was also voted upon. The 104 supporters of the Club at this point suggested a total of 46 additional titles to the original 9 in the proposal. That is a fantastic input of interest!

It needs to be properly treated! Therefore, the Initial Directors voted to call our Newsletter: <u>STUTZ NEWS</u> until a committee could be assembled to consider all the inputs and suggest alternatives.

It is a great pleasure to announce that the illustrious historian, author, editor, the renowned Beverly Rae Kimes, has agreed to chair the selection committee. You will hear loads about this important, and, I believe, critical aspect in future issues of STUTZ NEWS.

- 3. The Directors fully agreed that Membership Dues of 1988 should be as follows:
 - a) ACTIVE: \$20.00 for owners and enthusiasts in the U.S.A. Members living outside the U.S.A will pay \$25.00 plus extra for air mail postage yet to be determined.
 - b) LIFE: In 1988, Life membership will be available and encouraged as follows:

U.S.A.: \$300.00 outside U.S.A.: \$375.00

(15 times the active dues)

The Life Members will be so noted forever in the Club Directory. Life membership for future years will be considered and established by the Board.

c) FOUNDING LIFE: U.S. \$1,000.00 for all

Those in 1988 who contribute a minimum of \$1,000.00 U.S. dollars in cash or out of pocket contributions, will be forever recorded as Founding Life Members. They will be recognized also at all National Events and in all STUTZ publications.

Do, please, allow me a little pitch here! The funding of the Club is most critical to its future viability and overall service to us. A number of us are willing to be Founding Life Members to assure that the Club will continue in future years to serve us, to establish a master list of owners and vehicles, to prepare biographies, to maintain and expand the archives, to give us better publications, interesting articles, technical inputs, etc., etc.

Your significant contribution as a Life or Founding Member can make the difference between our STUTZ CLUB working as a "shoe string" operation or a great on-going, progressive, admired organization.

STUTZ is great! Let's fund it great!

4. Your Initial Directors feel that the first National Meet truly should be held in Indianapolis. One Director suggested Hershey, PA for the AACA Meet. But, that is such an overwhelming event; our STUTZ activities would be lost in the overall aspect of it and we would find it difficult to organize and be recognized.
